AVCO NEW IDEA FARM EQUIPMENT DIVISION AVCO DISTRIBUTING CORPORATION LAWN AND GARDEN TERMS AND CONDITIONS

1. SHIPMENT OF GOODS

All Garden Tractors, Attachments and Accessories are priced F.O.B. point of origin and such F.O.B. point for each unit is shown in the Company's current Suggested Price List. On Goods hauled or shipped from a location other than where manufactured, all transfer and transportation charges will be charged to the Dealer.

2. TRADE DISCOUNT

The prices quoted on Tractors, Attachments, and Accessories as defined in the Company's Suggested Price List will be subject to a Trade Discount of twenty-five percent (25%) for Models EGT 80, EGT 100, EGT 120, EGT 150, and EGT 200 Electric Garden Tractors.

The prices quoted on the Electric Riding Mower as defined in the Company's Suggested Price List will be subject to a Trade Discount of twenty percent (20%) for the Model R-36.

TERMS

(a) Tractors (including Power Packs):

Final due twelve (12) months from first day of month following date of shipment with curtailment of 10% and interest (Item 9) applied on units remaining unpaid six (6) months from the first of the month following date of shipment.

(b) Attachments

- Attachments will take the same terms as tractors provided they have a total invoice price of \$200.00 or more.
- (2) Attachments having a total invoice price less than \$200.00 are due on the tenth (10) calendar day of month following date of shipment.

(c) Accessories

Due on the tenth (10) calendar day of the month following date of shipment.

4. DUE DATES

For the purpose of determining any Due Date, shipments made after the Dealer's statement cut-off date shall be considered as having been made on the first of the following month.

SETTLEMENT

Upon the sale of any Goods to a customer, the purchase price of such Goods shall thereupon immediately become due and payable irrespective of any Due Date, and the Dealer shall make immediate and full cash settlement to the Company. The Company reserves the right to require immediate payment in the event any Goods are not properly maintained in a complete and undeteriorated condition as originally shipped; normal wear and tear excepted.

TAXES AND IMPORT DUTIES

Any taxes or import duties imposed by law will be added to the price of the Goods either as a separate item, or included in the invoice price of the Goods, as the law may require or the Company may determine.

7. NET CHARGES

All charges for items not otherwise covered in this Agreement, such as transfer and transportation, handling, promotional and advertising materials, etc. are net cash items upon receipt of statement.

8. REPAIR PARTS

- (a) All Repair Parts will be billed to the Dealer at Dealer's Net Invoice Price in effect on date of shipment as shown in the current Suggested Price List. They will be priced F.O.B. point of shipment.
- (b) The Due Date will be the Tenth (10th) of the month following date of shipment.

INTEREST ON PAST DUE

Interest will be charged on all past due indebtedness at the rate of ten percent (10%) per annum if permitted by law; otherwise, at the highest contract rate permitted by law.

LAWN AND GARDEN WARRANTY

CUSTOMER WARRANTY

TRACTORS, ATTACHMENTS AND ACCESSORIES

Subject to the warranty terms and conditions set forth herein AVCO NEW IDEA Farm Equipment Division, AVCO Distributing Corporation warrants its lawn and garden products to be free from defects in material or workmanship for a period of (1) year in ordinary home use (3 months if in commercial or institutional use) following the date of sale to the original purchaser.

POWER PACK (Batteries)

Subject to the warranty terms and conditions set forth herein AVCO NEW IDEA Farm Equipment Division, AVCO Distributing Corporation warrants that it will replace any individual garden tractor power pack unit with which this warranty is furnished if it fails because of defects in material or workmanship for:

12 Volt Power Pack — 1 year full warranty and 2 year pro rata for ordinary home use (6 months in commercial or institutional use) following the date of sale to the original purchaser. After 1 year in home use, but within 36 months following the date of purchase a power pack will be replaced at a pro rata service charge equal to 1/36th of the list price for replacement unit multiplied by the number of months which have elapsed from the date of original purchase to the date of failure.

The charge for service labor during the first (1) year in ordinary home use (3 months if in commercial or institutional use) will be covered under warranty. Service labor after the first (1) year is the responsibility of the owner.

A replacement unit will carry the above (1) year warranty and thereafter will be considered to be installed on the same date as the other units in the power pack for pro rata adjustment.

6 Volt Power Pack — 2 year full warranty and 3 year pro rata for ordinary home use (6 months in commercial or institutional use) following the date of sale to the original purchaser. After 2 years in home use, but within 60 months following the date of purchase, a power pack will be replaced at a pro rata service charge equal to 1/60th of the list price for replacement unit multiplied by the number of months which have elapsed from the date of original purchase to the date of failure.

The charge for service labor during the first (1) year in ordinary home use (3 months if in commercial or institutional use) will be covered under warranty. Service labor after the first (1) year is the responsibility of the owner.

A replacement unit will carry the above (2) year warranty and thereafter will be considered to be installed on the same date as the other units in the power pack for pro rata adjustment.

WARRANTY TERMS

Any parts that are proved, in the Company's judgment, to be defective during the above period will be repaired or replaced, free of charge and without charge for installation, at the place of business of an AVCO NEW IDEA Lawn and Garden Dealer. It is the purchaser's obligation to bring the product or parts to the Dealer's place of business. If this is not possible, it is the purchaser's obligation to reimburse the Dealer for travel time and travel expenses incurred in fulfilling this warranty.

The Dealer will properly set up and adjust the product at time of delivery. This warranty shall not entitle the purchaser to any further adjustments or normal maintenance services.

The warranty shall not apply to any Garden Tractor, Power Pack, accessories or attachments which have been repaired or altered in any way so as, in the Company's judgment, to affect its reliability, or which has been subject to misuse, negligence or accident, or attachments mounted on tractors which are not included in the Company's approved list, or repair parts which have not been approved by the Company for use in connection herewith.

THE ONLY REMEDY FOR ANY BREACH OF WARRANTY AND THE ONLY REMEDY FOR THE COMPANY'S LIABILITY OF ANY KIND, INCLUDING LIABILITY FOR NEGLIGENCE, WITH RESPECT TO ANY PRODUCT, SHALL BE LIMITED TO THE REPAIR OR REPLACEMENT OF ANY DEFFECTIVE PARTS AS STATED ABOVE, AND SHALL IN NO EVENT INCLUDE ANY INCIDENTAL OR CONSEQUENT DAMAGES.

THIS WARRANTY IS IN LIEU OF ANY OTHER WARRANTY, EITHER EXPRESSED OR IMPLIED.

DEALER WARRANTY COVERAGE AND ADJUSTMENT POLICY

The Company shall be under no liability whatsoever if any different or additional warranty shall be given to the purchaser, or if any provision of such warranty be waived or extended by the Dealer. The Company reserves the right to change the form of warranty at any time, but no such change shall affect the warranty with respect to Products theretofore sold and delivered by the Company.

The Dealer shall furnish to the Company definite proof of the delivery date of the Product to the purchaser prior to the Company's honoring any warranty claim. The Dealer shall furnish such proof by completing the warranty registration form, No. A-188 at the time of delivery of the Product to the purchaser.

The Dealer shall submit each warranty claim to the Company within thirty (30) days after the defective part has been replaced or repaired. Dealers are required to keep all defective parts on hand until 90 days after the warranty claim has been approved.

All parts alleged to be defective under the Company's warranty shall be made available for examination by the Company's representative either at the Dealer's place of business or at a designated Regional Center or Factory of the Company, at the Company's option. If examination is to be made at a Regional Center or Factory of the Company, the part shall be returned to the Company with transportation charges prepaid only after receipt by the Dealer of written shipping instructions from the Company.

After the Company has determined that the part is defective under the warranty the Dealer will be reimbursed as follows:

- For parts used to replace defective parts, the Dealer's net price as shown in Company's current Suggested Price List plus 5% for handling.
- For labor used by the Dealer to replace or repair defective parts, at the Dealer's retail customer labor rate, which shall be the labor rate agreed upon and on file with the Company. The hours allowed for performing such replacement or repairing will be the standard hours established by the Company.
- 3. Repair Parts are warranted for ninety (90) days from date of replacement, or for the remainder of the period of the warranty on the new Product, whichever is longer. The labor allowance referred to in paragraph 2 above, however, shall apply only to installations performed during the warranty period on the new product.

The Dealer shall send a competent service man to all Dealer service meetings or Dealer service schools sponsored by the Company and held for Dealers from his area. If he shall fail to send a competent service man to such meetings the Company may, at its option, refuse to reimburse him for the labor allowance outlined above.

The Dealer shall, at his expense, set up and/or install the Product and make all necessary adjustments at the time of delivery to the purchaser. Any further adjustments during the warranty period are not included under the warranty. If it is necessary to send a Company service man to make such adjustments the Company reserves the right, at its option, to invoice the Dealer for all expenses incurred by the Company in making such adjustment.

Whenever the Company notifies the Dealer that a part must be installed or an adjustment must be made on Products he has received, he will make such installation or adjustment immediately.

A. POWER PACK (BATTERY) ADJUSTMENT POLICY

Any battery which fails (not merely discharged) due to defects in material or workmanship within one (1) year for 12 volt battery and two (2) years for 6 volt battery will be repaired or replaced at the option of AVCO NEW IDEA Company, F.O.B. plant or common authorized place of business. (A battery failure is defined as inability of a 6 volt battery to carry a 75 ampere load down to 1.75 volts per cell for a minimum time of 60 minutes at an electrolyte temperature of 80°F. A battery failure is defined as inability of a 12 volt battery to carry a 50 ampere load down to 1.75 volt per cell for a minimum time of 40 minutes at an electrolyte temperature of 80°F.) There will be no charge except for transportation, recharging and rental service. Dealer labor and installation shall be reimbursed by AVCO NEW IDEA during the normal tractor warranty period. The replacement warranty is in effect within 150 days from the manufacturer's shipping date stamped on the battery. The dealer must maintain "first-in/first-out" inventory to be sure of protecting the owner's full warranty. The warranty on all "in-warranty" replacement units carries the normal (one (1) year for 12 volt and two (2) years for 6 volt) replacement warranty plus pro-rata warranty dating from the original date of sale of the Garden Tractor.

B. PRO-RATA SERVICE ADJUSTMENT

Any battery which becomes unserviceable (not merely discharged) after full warranty period, but before the expiration date of the service adjustment period, can be exchanged for a new battery on a pro-rata adjustment basis. The pro-rata cost is determined by dividing the current list price by the service adjustment period (36 months for 12 volt or 60 months for 6 volt) multiplied by the months of ownership. Charges to the owner are based on the number of months between the date of failure and the warranty date.

This warranty and pro-rata service adjustment policy does not apply in the following cases: damage due to neglect, abuse or explosion; if the container covers or posts are broken; if the battery has been opened, frozen cells, if electrolyte other than as recommended by the factory has been used; if the manufacturer's code markings have been destroyed; or if any battery used is of a size smaller than or of different origin than the one specified by AVCO NEW IDEA for use in electric Garden Tractors.

In the event of an adjustment, the dealer will issue a pro-rata adjustment, Form No. A-188, upon assurance of warranty registration, to cover the details of the failure of the battery. This pro-rata service adjustment is void if the battery is transferred to another owner. If some proof is not available of the original purchase of the battery, it should be assumed the battery was purchased in the month and year shown by the manufacturer's code date.

This warranty covers only a battery with AVCO NEW IDEA IDENTIFICATION ON IT.
